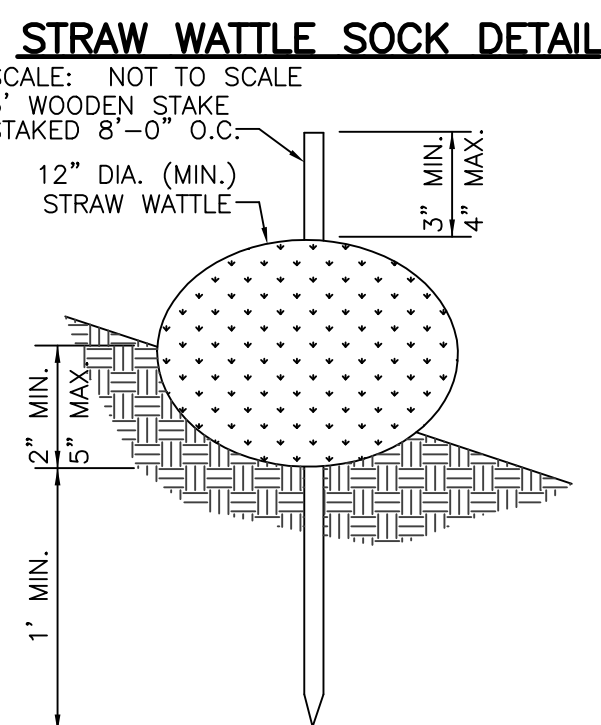
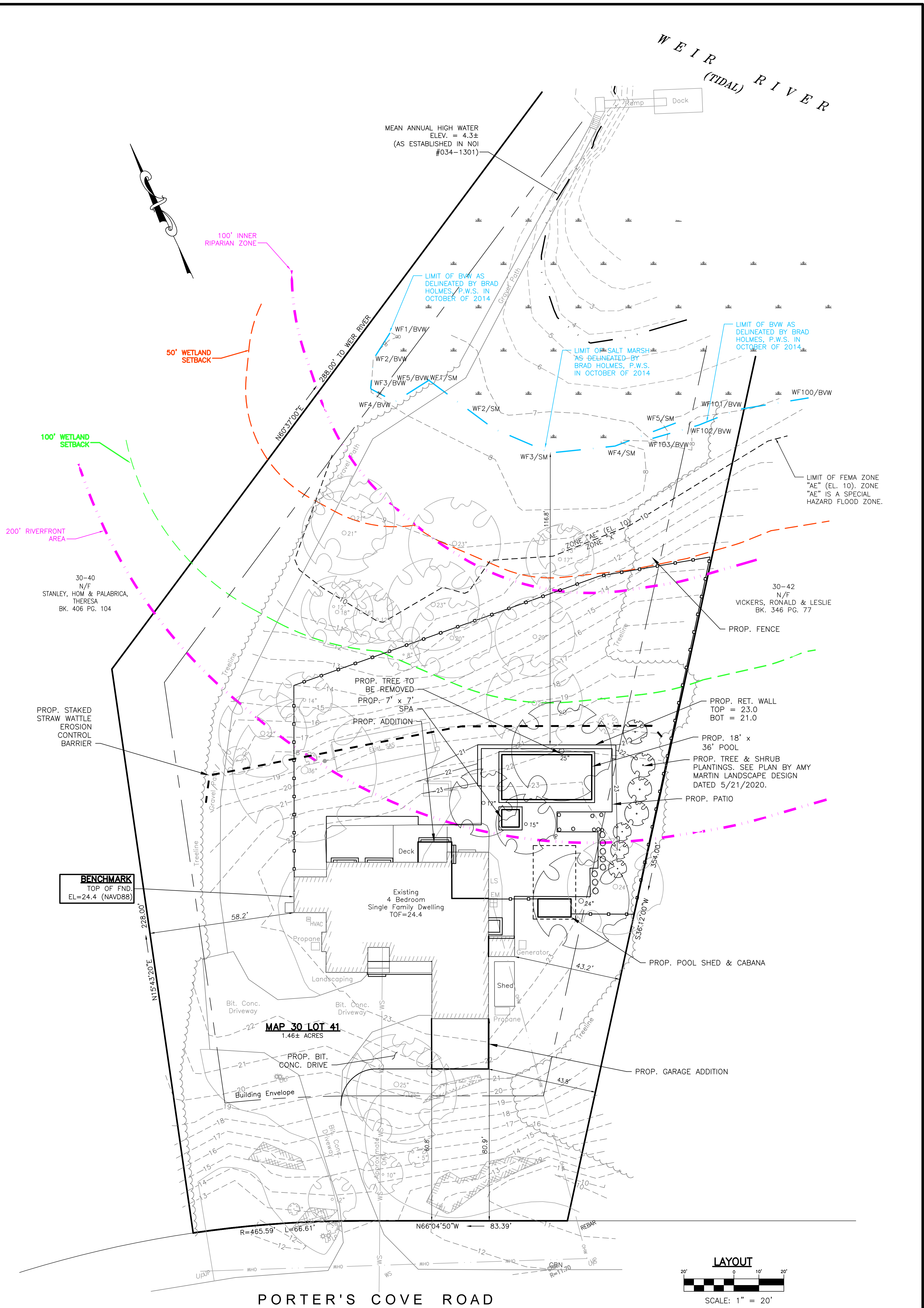


VICINITY MAP

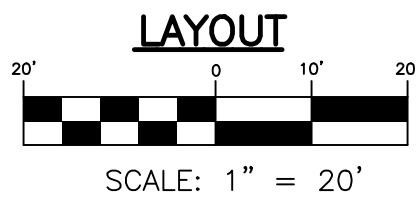
